#### METREX Acronym for METRopolitan Exchange

- Founded in 1996 at its first conference in Glasgow
- Is an independent network funded by its members
- Is a network for 'practitioners' of public institutions

#### Its members are from

- Formally established regions
- Formally established collaborations between local governments
- Informally organised collaborations between local governments

# **INTA45** From City to Civitas

Local Government is still best in place to

- Best know their needs
- Be close to their citizens and civil society, to people
- Develop tailored solutions for their needs
- But they need to upscale:

# What is the matter?

#### Only some issues

- Our core European cities are at least 150 years old. They need heavy maintenance, especially on infrastructure (sewer, water, etc)
- Our city extensions have used a lot of land, often at a considerable distance from the core(s), with transport issues as a consequence.
- Our economy globalized, with even bigger transport issues, not to mention our vulnerability.
- We still know little from climate issues, especially the interlinkages between phenomenon and the, often, accelerating characteristics.
- New media has completely changed our way of living and we are only at the start of it.
- A firm basis of regional economy are SME-s (emphasis on S), we often neglected them and they disappeared.

Most issues have serious environmental impact

These, and many more, are seen as **risks** that influence the price of financing future, necessary (urban) intervention (EIB)



### What is the matter?

For a lot of individual issues, we can develop frameworks for solutions, together with the scientific community, to have local communities tailor them to their taste

But

**On top of that, we have to deal with an Increasing complexity,** of our society, of our institutions and regulations etc.

We have to deal with very complicated matters, for which 'integrated thinking' or linking them to each other, is extremely important but also very difficult. All of this on top of our daily business

Our subnetwork group SURE is looking into circularity and what it means for planning, for policies. You cannot imagine.



# **INTA45** From City to Civitas

#### Have cities grown out of control?

- For many issues **yes**, at least municipalities have.
  - The main challenges cross borders into neighboring authorities
  - The increasing complexity asks for a different approach in many things
  - They are growing short of resources
- Without taking away the closest representative level, we believe upscaling of governance and operational services is the way forward
- And that upscaling of local government can help them level with the 'big players' in the regions
- Are we capable for such actions?



### What actions are needed within ?

But we need to learn that, so

# **Capacity Building**, especially for medium and small size cities, and urban AND rural areas

Invest in people

#### De-Silo-isation, also in government institutions

This could be done by working with thematic programmes

like the Green Deal

Local Governments (including their rural areas) should be better equipped to translate often abstract national and EU policies in action

*After all, they are the ones that can develop concrete and place-based solutions* 



#### Are we capable for actions?

YES, but

We need to re-position our institutions

#### We need to re-think our policies

*e.g. work much more in programmes (like the EU Green Deal or Rural Pact) instead of rigid plans and policies* 

*Cities have shown, over the centuries, the ability to adapt and redevelop* 

Make much better use of metropolitan regions and cities, closer to its people and businesses

And therefore

Develop EU and national programmes (cross silos) with funds that are directly accessible for Metro regions and cities.



#### METREX is developing a Metropolitan Vision for Europe 2050

It gives our view on the role that local government can play in addressing the current and future challenges we all face.

The vision will be ready at our METREX Spring Conference in Wrocław, 23-26 April The vision will be launched in Brussels at the European Parliamentary Urban Intergroup in June 2023.
